Bid suppression exists when competitors agree not to tender a bid to ensure that the pre-agreed competitor will win the contract.

Cover bidding exists when competitors choose a winner and everyone but the winner deliberately bids above an agreed amount to establish the illusion that the winner's bid is competitive.

⁴ **Market allocation** exists when competitors agree to designate bid winner in advance on a geographical or customer allocation basis.
