- GPS Antenna with at least 10m cable or any other source of GPS
- With Automatic Time Synchronization: clocks automatically adjust to the correct Philippine Standard Time without any manual setting of time. In case of brownouts, all clocks automatically re-adjust to the correct Philippine Standard Time once power is restored.
- Nominal LED Display Height: 5-inch, single-sided
- **Readable Distance:** 40 meters
- **Time Display:** Red-color dotted LED, Six (6) Digits [HH:MM:SS].
- **Time Format:** 12hr and 24hr capable
- Casing: Black, powder-coated metal, corrosion-resistant.
