- Price quotations to be denominated in Philippine Peso shall include all applicable government taxes subject to (BIR 2306) 5% R-VAT and (BIR 2307) 1% (PO) or 2% (JO) deductions.
- 5. PCC PBAC Technical Working Group may require you to submit documents that will prove your legal, financial and technical capability to undertake this contract.
- 6. Salient provisions of the IRR of RA 9184: Section 68 Liquidated Damages and Section 69 Imposition of Administrative Penalties shall be observed.
- 7. PCC reserves the right to reject any and all quotations, declare a failure, or not award the contract pursuant to Sec 41 of the same IRR.
- 8. In case of tie quotations, suppliers' presence are required during tie breaking through draw lots or toss coin.

### **Background**

The Philippine Competition Commission (PCC), in coordination with the Department of Trade and Industry (DTI) Bureau of Small and Medium Enterprise Development (BSMED), will conduct the Workshop on "Linking Competition Policy, Economic Recovery, and Resilience: Benefits to MSMEs" on 28 November 2022 in Quezon City.

The Workshop aims to i) discuss how micro-, small, and medium enterprises (MSMEs) can benefit from competition policy (both in the short-term and long-term), ii) provide elaboration of anti-competitive agreements/conduct prohibited under the Philippine Competition Act (with examples focused on MSMEs' operations), and iii) help identify actionable items to ensure that the benefits of competition policy accrue to MSMEs, especially in the post-pandemic era.

## I. Scope of Work

## A. Duties and Responsibilities

The service provider is mainly tasked to serve as described hereunder:

- Perform necessary documentation of the Workshop on "Linking Competition Policy, Economic Recovery, and Resilience: Benefits to MSMEs"

  – as source of video footage/photos, through video/still camera and ensure quality of captured video footage and still images;
- Process video presentations using Adobe Premier Pro or other similar audio-video editing software;
- Submit edited videos/photos within ten (10) calendar days after the event;
- Provide/use the service provider's own video and still camera equipment; and
- Cover transportation necessary to complete assignments

## II. Qualifications

The service provider must be:

- An individual or firm based in Metro Manila;
- With at least 2 years of relevant work experience in carrying out similar projects;
- With excellent skills in using Adobe Premier Pro or other similar video editing software; and



With excellent skills in using professional level video and still cameras.

## III. Professional Fee

The approved budget for the contract is **Sixty Thousand Pesos** (**PhP60,000.00**) inclusive of all applicable expenses and taxes. The payment shall be released upon the submission of billing statement, required outputs, and the PCC's certification of satisfactory service rendered.

## V. Confidentiality of Data and Information

To ensure protection of PCC information, service provider/s are expected to observe and abide by the established PCC Information Security Management System (PCC ISMS) and shall agree to sign a non-disclosure agreement.

All data, documents, records (collectively "Information") to be provided to the Service Provider for purposes of delivering the Services are considered confidential information and shall remain the sole property of PCC. The Service Providers shall acknowledge the importance of maintaining security and confidentiality of the Information and agree to prevent unauthorized transfer, disclosure, or use of these Information by any third person or entity. Service Providers shall not use the Information for any purpose other than in connection with the Services. Service Providers shall ensure that it will not retain, after completion of the Services with which the Information was provided, all or any portion of the Information, in any manner whatsoever.

Upon completion of the Services, any and all Information shall be deleted. The Service Provider shall not keep any copy of the Information in either digital or physical format, including, but not limited to notes, documents, memoranda, and other writing, electronic records, communications, and the like.

## VI. Liquidated Damages

Failure to comply with the Terms and Conditions of the contract will result in the payment of corresponding penalties/liquidated damages in the amount equal to one-tenth of one percent (.001%) of the cost of unperformed portion for every day of delay. If the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of contract, the PCC

reserves the right to rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

## VII. Dispute Agreement/Resolution

In the matter of dispute, should any dispute related to the Contract and/or rights of the parties arise, the same shall be submitted to mutual consultation, mediation and arbitration, in the order of application. The venue of the proceedings shall be in Quezon City.

In case of a court suit, the venue shall be the courts of competent jurisdiction in Quezon City, to the exclusion of all other courts; and

Any amendment or additional terms and conditions to the Contract must be in writing, signed and acknowledged by the Parties.

### VIII. General Conditions

Agency must grant copyright ownership of all videos, photos, audio both raw and edited to the Philippine Competition Commission. All edited/packaged materials should follow branding specifications of PCC.
