INSTRUCTIONS TO BIDDERS (IB)

Disposal of Used/Unserviceable Properties

I. Inspection of Used/Unserviceable Properties

The used/unserviceable properties for sale are available for inspection/viewing until **August 30, 2019, 10:00 AM** at PCC Office, 25/F Vertis North Corporate Center 1, North Avenue, Quezon City.

II. Schedule of Public Auction

The public bidding shall be conducted on one (1) and "as is, where is" basis by the PCC Property Disposal Committee (PPDC). Schedule of opening of bids is on **September 02, 2019, 1:00 p.m.** at the 25/F Vertis North Corporate Center 1, North Avenue, Quezon City.

III. Qualification of Bidders

Entities and individuals, including PCC employees, are qualified to participate in the public auction, subject to the submission of documentary requirements (see attached list) required by the PPDC.

Duly authorized representative/s, if any, shall submit a written authorization signed by its principal.

IV. Floor Price

Floor price properties per lot has been set in accordance with accounting and auditing rules and regulations (please refer to the attached List of Properties with Floor Price).

V. Submission of Bids and Bid Bonds

- 1. The bid must be submitted using the attached template (see attached Annex A) together with documentary requirements to the PPDC Secretariat, 25/F Vertis North Corporate Center 1, North Avenue, Quezon City, in a sealed envelope, and shall be labeled with the PPDC-IB No., the bidder's name, address and contact number.

Bidders shall place their bids inside the Bid Drop Box located in the Reception Area. The deadline of submission of bids is on August 30, 2019, 12:00 p.m. Bids submitted beyond said deadline shall not be accepted.

VI. Modification and Withdrawal of Bid

- 1. A bidder may modify its bid after it has been submitted, provided that the modification is received by the PPDC prior to the deadline of submission of bids.
- 2. A bidder may, through a Letter of Withdrawal, withdraw its bid after it has been submitted, for valid and justifiable reason; provided that the Letter of Withdrawal is received by the PPDC prior to the deadline of submission of bids. A bidder that withdraws its bid shall not be permitted to submit another bid for the same project.
- 3. Modification/Withdrawal of bids shall not be allowed after the deadline of submission of bids.

VII. Opening of Bids

- 1. Opening of bids will be on **September 02, 2019, 1:00 PM** in the presence of at least 1 PPDC member and the bidders who chose to attend.
- 2. An Abstract of Bids shall be prepared by the PPDC Secretariat for signature of the PPDC members and approval of the Head of the Agency or his authorized representative.

VIII. Awarding of Bids

- 1. Award shall be made to the highest bidder;
- 2. Tie bids shall be resolved by the PPDC through draw lots to determine the winning bidder; and
- 3. If the winning bidder refuses to accept the award, the next highest bidder shall be given the award.

IX. Payment

- 1. One-time payment in cash shall be made within five (5) calendar days from the date of receipt of the Notice of Award;
- 2. Payment through salary deduction, in case of winning bidders from PCC, shall not be allowed; and
- 3. An Official Receipt shall be issued by the PCC for the payment made by the winning bidder.

X. Pick-up/Hauling of the Property by the Winning Bidder

- 1. The winning bidder shall be given five (5) calendar days from receipt of the Notice to Proceed, to pick-up and haul the property;
- 2. Expenses incidental to the pick-up/hauling of the property shall be borne by the winning bidder; and
- 3. In case the winning bidder fails to complete the pick-up/hauling of the property within the prescribed period, the award shall be revoked/cancelled. The next highest bidder shall be awarded the bid.

XI. Forfeiture and Return of the Bid Bond, and Blacklisting

- 1. The Bid Bond shall be forfeited in favor of PCC in the following instances:
 - a. If the winning bidder refuses to accept the award;
 - b. In case the winning bidder fails to make the payment within the prescribed period, and
 - c. If the winning bidder fails to complete the pick-up/hauling of the property within the prescribed period.
- 2. The Bid Bond shall be returned to the concerned bidder/s after the winning bidder has completed the pick-up/hauling of the properties.

Any bidder who refuses to accept the award and fails to make the corresponding payment shall be blacklisted and disqualified to participate in the future biddings of PCC, without prejudice to other appropriate or legal action and remedies.

XII. Failure of Bidding

Failure of bidding shall be declared in the following instances:

- 1. If prospective bidders are declared ineligible;
- 2. No bids are received;
- 3. All bids fail to comply with the bid requirements;
- 4. All bids are below the floor price;
- 5. The winning bidder refuses to accept the award; or
- 6. The winning bidder fails to make the payment as required.
