### VII. Payment Scheme

The PCC shall pay the Service Provider upon submission of the statement of account/billing statement with the corresponding monthly billing rates stipulated in the contract subject to existing government auditing and accounting rules and regulations, for and in consideration of the services rendered by the employees deployed by the Service Provider; and upon submission of its monthly payment and affidavit or sworn certification that it has paid the salaries and benefits of its employees for the period covered, per submitted and remitted payroll the corresponding premiums to SSS, Pag-PhilHealth, payment IBIG, withheld compensation taxes to BIR Employees' Compensation Commission (if any).

### **VII. Payment Scheme**

The PCC shall pay the Service Provider upon submission of the statement of account/billing statement with the corresponding monthly billing rates stipulated in the contract subject to existing government auditing and accounting rules and regulations, for and in consideration of the services rendered by the employees deployed by the Service Provider; and upon submission of its monthly payment and affidavit or sworn certification that it has paid the salaries and benefits of its employees for the period covered, per submitted payroll corresponding and remitted the premiums Pag-IBIG, to SSS, payment of withheld PhilHealth, compensation taxes to BIR and Employees' Compensation Commission (if any).

A separate billing statement shall be applied incase of increase in monthly contributions such as SSS, PhilHealth, Pag-IBIG and other agencies authorized by the Government of the Philippines. The latest issuance of rates shall be applied.

Amendments/inclusions/clarifications made herein shall be considered an integral part of the Bidding Document.
