#### E. Question and Answer

- Representatives from E-Copy Corporation and Data Images were present during the pre-bid conference.
- The following questions/concerns were raised during the meeting:
- Mr. Corcino of Data Images raised the concern on the date of opening of bids as published in the PhilGEPS. Per PBAC Secretariat in-charge of the project, a supplemental bid bulletin was already issued to reflect the new dates of bid submission and opening. Said document will be emailed to both bidders due to error of downloading files from PhilGEPS.
- Mr. Corcino verified if Secretary's Certificate will be included in the financial component. Per PBAC Secretariat, said document will be submitted together with the Omnibus Sworn Statement, which is not part of the financial component.
- Mr. Corcino clarified if PhilGEPS platinum certificate will be a sufficient submission in lieu of Class A documents, which was confirmed by the PBAC Secretariat. Further, it was clarified that Class A documents may be required during the postqualification.
- 4. Mr. Corcino queried on the requirement under Section II.C.1 of the Terms of Reference, as to the definition of newly remanufactured. Per Mr. Fajutnao, it was included in the TOR to ensure that machines to be deployed to PCC are in good working condition. Further, bidders were advised to include the brochure for verification of the specifications, and the

	certification that machines are in good working condition/ certificate of manufacturing date.	
5.	Mr. Corcino clarified if the certification to be provided should be issued by the manufacturer. Ms. Dizon queried on the bidder if they can provide a certification of manufacturing. Per Mr. Corcino, for remanufactured machines, Japan manufacturer will not provide a certification. The bidder can issue certification that machines are in good working condition and consumables were replaced in lieu of the certification. Atty. Basas verified the provision in the TOR as to the certification.
