5.	Mr. Iliscupidez inquired about the interview if other options like an online facility can be used instead of a face-to-face interview. Ms. Ty asked Mr. Iliscupidez on how they can ensure that the	
	target respondent did the interview. Mr. Iliscupidez responded that they require a certificate from the respondents. Mr. Celicious further discussed that the questions in the online facility are created in such a way that only the target respondent can answer. Ms. Ty asked for the procedure if the screener questions failed. Mr. Iliscupidez responded that ASCEND has placement procedures which should also be included in the enumerator's manual. Ms. Ty insisted to enforce the face-to-face interview as stated in the Terms of Reference and that part of the sampling design includes alternate respondents in case of non-response.
