1	. If PCC will provide copy of the Pre-Bid presentation to the bidders as reference for the list of requirements and proper packaging, sealing and marking of bids.	All queries were clarified. Thus, there is no need to issue bid bulletin.
	Mr. Suing explained that the slides presented are for pre- bidding conference presentation only. The checklist of requirements as well as the proper packaging, sealing and marking of bids are all included in the Philippine Bidding Documents.	
2	. If PCC will accept Bid Securing Declaration for the Bid Security Requirement.	
	Mr. Fajutnao confirmed that Bid Securing Declaration is acceptable for the said requirement.	
3	 If PCC can provide the consultant the current framework used by the End-User. Mr. Paguia clarified that the query raised by Ms. Velecina can be discussed during contract implementation. 	
4	Whether the End-User has set a minimum or desired sample size for the conduct of survey.	
	Mr. Paguia responded that it is the discretion of the consultant on how the survey will be conducted and will depend on the focal persons assigned by each office.	
5	. Clarified the period on the long-term training program to be provided by the consultant.	
	Mr. Paguia confirmed that it is a 5-year program which is intended for CKMO-KMD.
