#### E. Questions and Answers

- The PBAC Chairperson opened the table for questions, clarifications, and concerns regarding the procurement project:
  - 1. Mr. Amarille of Securemetric Tech, queried if a project under foreign company is acceptable to indicate in the SLCC.
    - ➤ Mr. Fajutnao of the PBAC Secretariat responded that the foreign projects will be allowed & accepted but should be converted into Philippine Peso.
  - 2. Mr. Amarille of Securemetric Tech, queried if it is applicable to pay the bidding documents through online payment.
    - ➤ The PBAC Chairperson, responded that the portal or online payment is not yet operational and the bidders are advised to transact personally at PCC Cashier office.
  - 3. Mr. Dimaano of Securemetric Tech, queried if the No.3 item on the Terms of Reference is mandatory requirement, the customization of branding and logo for email or it should be on interface.
    - ➤ Ms. Allera of the End-user, responded that the listed items on the Terms of Reference are the minimum requirements, any of these can be part of the solution but the generation of automatic email reminder and notification are required.
- The PBAC Chairperson reiterated that the PCC is implementing a No Gift Policy and is not soliciting any money or favor for any purpose. Bidders should be aware of the scammers soliciting donations or gifts using PCC Officials' name.
