	• The PBAC Vice-Chairperson opened the table for questions, clarifications, and concerns regarding the procurement project:	





- 1. Mr. Raymond De Guzman of Microdata queried if the subscription period will begin on January 2021 for the 50 users requirement of the PCC.
 - ➤ The end-user confirmed that the subscription period for all the 50 users will begin on January 2021.
- 2. Mr. De Guzman also asked if the requirement is pertaining to particular product like Adobe or any product that will suffice the requirement.
 - ➤ The end-user mayissue bid bulletin to clarify the question raised.
- 3. Mr. De Guzman queried if there is a preferred format or template of the generated report to be required by the end-user.
 - The end-user may issue bid bulletin to clarify the required details of the generated report.
- 4. Ms. Christine Ocampo of My Busybee Inc. asked if the Single Largest Completed Contracts (SLCC) pertains to any cloud-based e-signature or any Adobe products
 - ➤ The end-user responded that the SLCC should be similar to the procurement project which is cloud-based e-signature.
- 5. Ms. Lea Solinap of Ynzal Marketing asked if the SLCC should be government or private contract.
 - ➤ The end-user responded that there were no specific requirements for the contract to be indicated for SLCC as long as it is similar to the procurement project.
- 6. Mr. De Guzman of Microdata queried if the perpetual licenses can be considered for the procurement project.
 - ➤ The end-user responded that they are requiring a subscription-based licenses.
- The PBAC reiterated the strict implementation on the deadline of submission of bids, which is on 07 December 2020, 12:00NN
