7. Mr. Eugenio also informed that there are volumes that are not included in the list provided, namely: Volume 1 2013 and Volume 69 2013 of Fletcher Cyclopedia.	Agreements non-delivery of all the items is considered unperformed. Thus, non-delivery of the volumes which are out of stock within the period given by the End User will incur liquidated damages based on the total amount of the contract. End User will validate the volumes mentioned. Nevertheless, inclusion of the said volumes will not affect the ABC considering that the purchase is made per set and not per volume. Considering the same, the End User may also opt removing the list and simply provide "complete set" of the Fletcher Cyclopedia. Clarification will be included in the bid bulletin.
8. As regards the Anti Trust Law series, Mr. Daran also clarified the double entry of volumes. Further, it also clarified that Volumes IX onwards are Third Edition only, and not Fourth Edition.	Double entry of volumes are typographical errors. As regards the book edition, End User will provide clarification for inclusion in the Bid Bulletin.
9. Mr. Daran also asked whether the Single Largest Completed Contract (SLCC) includes contracts involving magazine and journal subscriptions.	The PBAC agreed to include magazine and journal subscriptions as SLCC.
