1.	The factor or total number of working/paid days per year as prescribed by the National Wages and Productivity Commission for those who do not work and are not considered paid on Saturdays and Sundays or rest day is 164. The divisor used in the Terms of Reference is 264.	A supplemental bid bulletin will be issued to correct the following: 1) factor or number of working/paid days per year, and 2) rate of PhilHealth
	The end user explained that the fixed number of 22 days per month was used in the computation. A supplemental bid bulletin will be issued to correct the error.	contribution.
2.	The PhilHealth Contribution used in the Annex C and D of the Terms of Reference is higher than the prescribed rate for 2020.	
	The end user explained that the rate used was the rate for 2021. Nevertheless, a supplemental bid bulletin will be issued to reflect the current PhilHealth rates.
