RECOMMENDING THE AWARD OF CONTRACT THROUGH DIRECT CONTRACTING TO OTUS COPY SYSTEMS INC. FOR THE PURCHASE OF TONER CARTRIDGES FOR FUJI XEROX DOCUPRINT C2255 PRINTER

WHEREAS, the Philippine Competition Commission (PCC) has allotted in its *Annual Procurement Plan (APP) CY 2019* with an approved budget for the contract (ABC) of *One Hundred Forty Four Thousand Pesos (PhP144,000.00)* for the *“Purchase of Toner Cartridges for Fuji Xerox Docuprint C2255 Printer”*;

WHEREAS, Section 50 (c) of the revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows procuring entities to use Direct Contracting as an alternative mode of procurement when certain product or service is “sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government of the Philippines.”;

WHEREAS, in the certification issued by Fuji Xerox Philippines Inc, the Otus Copy Systems, Inc. is the authorized seller of Fuji Xerox products and is the exclusive agent for consumables, parts and services for equipment and accessories.

WHEREAS, Otus Copy Systems, Inc. has tendered a price quotation for the following items:

2. Recommend to the Head of Procuring Entity the approval of the Notice of Award and Purchase Order.




