## PBAC Resolution No. 201903-0029

RECOMMENDING THE AWARD OF CONTRACT TO CROWNE PLAZA GALLERIA – MANILA THROUGH NEGOTIATED PROCUREMENT FOR LEASE OF VENUE (NP-LRPV) FOR THE PROVISION OF VENUE INCLUDING FOOD FOR THE PUBLIC FORUM ON THE PCA FOR MSMES AND COOPERATIVES ON 29 APRIL 2019

WHEREAS, the Philippine Competition Commission (PCC) has allotted in its Annual Procurement Plan (APP) an Approved Budget for the Contract (ABC) of One Hundred Ninety-Two Thousand Pesos (Php 192,000.00) for the provision of venue including food for the conduct of Public Forum on the PCA for MSMEs and Cooperatives on 29 April 2019;

WHEREAS, Section 53.10 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 allows the use of Negotiated Procurement for the Lease of Venue, subject to Annex H of the said IRR;

WHEREAS, Request for Proposal (RFP No. 201903-0050) for the said procurement was conveyed to prospective service providers, namely: Sequuia Hotel, Crowne Plaza Galleria – Manila, Prime Hotel, Eastwood Richmonde Hotel, Luxent Hotel, Novotel Manila Araneta Center, and Seda Vertis North;

**WHEREAS**, of the service providers invited, the following submitted proposals with corresponding end-user/TWG ratings:

WHEREAS, based on the evaluation and recommendation of the End-User / Technical Working Group in its memorandum dated 22 March 2019, the PBAC finds the proposal of Crowne Plaza Galleria – Manila as the lowest calculated and responsive bid in the total amount of One Hundred Eighty Thousand Pesos (Php 180,000.00);

WHEREAS, Section 12 of RA 9184 mandates the BAC to recommend the award of contract to the Head of Procuring Entity (HOPE) or his/her duly authorized representative.





## NOW THEREFORE, the PBAC has RESOLVED, as it hereby RESOLVES to:

- 1. Recommend the award of contract to Crowne Plaza Galleria Manila for the provision of venue including food for the conduct of Public Forum on the PCA for MSMEs and Cooperatives on 29 April 2019 in the amount of One Hundred Eighty Thousand Pesos (Php 180,000.00), inclusive of all applicable taxes;
- 2. Recommend to the HOPE the signing of Job Order to implement the said contract.
