**CONTRACT AGREEMENT**

**MANPOWER SERVICES PROVIDER FOR THE PLRP PROJECTS  
UNDER 2019 CONTINUING FUNDS**

This AGREEMENT made on the ~~19th~~ day of November 2020 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "*the Entity*") of the one part and *LSERV Corporation (Formerly LBP Service Corporation)* represented by its Vice President, Mr. Generoso T. Canlas, Jr. with business address at Units C & D, 21<sup>st</sup> Floor, Petron Mega Plaza Building, 358 Sen. Gil Puyat Ave., Makati City 1200 (hereinafter called "*the Service Provider*") of the other part:

WHEREAS, the Entity invited Bids for the *Engagement of Manpower Services Provider for the PLRP Projects Lots 1 and 2* and has accepted a Bid by the Service Provider for the Lot 2 – Engagement of Manpower Services Provider for the PLRP Projects under the 2019 Continuing Funds in the sum of *One Million Five Hundred Seventy Eight Thousand Five Hundred Seventy Five Pesos and 94/100 (PhP1,578,575.94)*, inclusive of applicable taxes (hereinafter called "*the Contract Price*");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - (b) the Conditions of Contract;
  - (c) the Conformed Terms of Reference;
  - (d) the Eligibility Documents;
  - (e) the Performance Security; and
  - (f) the Entity's Notice of Award of Contract duly accepted by the Service Provider.
2. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby covenants with the Entity to execute and complete the project, and to remedy any defects therein in conformity with the provisions of this Agreement in all respects.
3. The Entity hereby agrees to pay the Service Provider in consideration of the execution and completion of the project, the Contract Price under the provisions of this Contract at the time and in the manner prescribed by this Contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


