# RECOMMENDING THE AWARD OF CONTRACT THROUGH DIRECT CONTRACTING TO IQVIA LTD. FOR THE PROCUREMENT OF COUNTRY DATASETS FOR PCC REGIONAL BENCHMARKING FOR PRICING IN PHILIPPINE PHARMACEUTICAL SECTOR

WHEREAS, the Philippine Competition Commission (PCC) has allotted an Approved Budget for the Contract (ABC) of *Two Million Pesos* (*PhP2,000,000.00*) for the "Procurement of Country Datasets for PCC Regional Benchmarking for Pricing in Philippine Pharmaceutical Sector";

WHEREAS, Section 50 (c) of the revised Implementing Rules and Regulations (IRR) of RA No. 9184 allows procuring entities to use Direct Contracting as an alternative mode of procurement when certain product or service is "sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government of the Philippines.";

WHEREAS, in its duly authenticated and apostilled certification by the United Kingdom of Great Britain and Northern Ireland, IQVIA Ltd. (IQVIA) has certified that the data requirement is proprietary to IQVIA (ref. 24 September 2021 letter);
