



PHILIPPINE COMPETITION COMMISSION PROPERTY DISPOSAL COMMITTEE (PPDC)

Resolution No. 2021-04-002

Recommending the Award to the Highest/Single Calculated and Responsive Bidders for the Disposal of Unserviceable/Unnecessary Property and Equipment of the Philippine Competition Commission.

WHEREAS, the Philippine Competition Commission (PCC) has determined the unserviceable or unnecessary equipment and properties for disposal based on the approved Inventory and Inspection Report of Unserviceable Property (Annex A);

WHEREAS, pursuant to Section 5.6.1 of the PCC Office Circular No. 2018-09-002, disposal of government property shall be undertaken through public auction and other recognized modes, such as donation and transfer;

WHEREAS, on 14 April 2021, Invitations to Bid for the said disposal were posted at the PCC website and in its conspicuous place, likewise conveyed to prospective bidders, namely: (1) Sorm Trading, (2) FJMDC Merchandise, (3) Malachi Trading, (4) G.A. Trading, (5) SGP Junkshoph, (6) Dekada Collectibles, (7) Lexton Trading, and PCC employees;

WHEREAS, after the set deadline of submission on 26 April 2021, 12:00NN, eight (8) bidders submitted their financial bids along with the required documentary requirements (*attached as Annex B - Abstract of Bids*);

WHEREAS, PPDC opened the bids on 26 April 2021, 2:00 PM and determined that the bids for specific lot compliant with the eligibility and financial requirements PPDC.
