SUPPLY AND DELIVERY OF TWO (2) BRAND-NEW MULTI-PURPOSE MOTOR VEHICLES FOR THE PHILIPPINE COMPETITION COMMISSION

CONTRACT AGREEMENT

THIS AGREEMENT made on the 1st day of September 2022 between the **Philippine Competition Commission** (PCC) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City of the Philippines (hereinafter called "the Entity" or "PCC") and **Toyota Quezon Avenue**, **Inc.** with office address at 728 Quezon Avenue, Quezon City (hereinafter called "the Supplier" or "Toyota");

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply and Delivery of Two (2) Brand-New Multi-Purpose Motor Vehicles for the Philippine Competition Commission and has accepted a Bid by the Supplier, declared as the Single Calculated Responsive Bidder, for the supply of the said goods and services in the sum of Two Million Six Hundred Fifty-Nine Thousand Pesos (PhP2,659,000.00). (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any;
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The Supplier agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of **Two Million Six Hundred Fifty-Nine Thousand Pesos (PhP2,659,000.00)** or such other sums as may be ascertained, **Toyota, the Supplier,** agrees to supply and deliver the goods required, provide the ancillary services relative to it, and to remedy any defects therein, in accordance with its Bid.
- The PCC agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
