CONTRACT AGREEMEN 2022

THIS AGREEMENT made on the \_\_\_\_ day of \_\_\_\_ (the "Agreement") between the Philippine Competition Commission represented herein by its Executive Director and Head of Procuring Entity, Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter referred to as the "Entity"), and Infocentric Solutions, Inc., represented herein by its Account Manager, Marjorie A. Ona, with office address at 19/F Marco Polo Hotel Ortigas Sapphire Road, Ortigas Center, Pasig City (hereinafter referred to as the "Supplier") (collectively referred to herein as the "Parties");

WHEREAS, the Entity invited bids for certain goods and ancillary services for the *Procurement* of Comprehensive ICT Maintenance Services for the Philippine Competition Commission Data Center Infrastructure (Lot 1: Hyperconverged Server Infrastructure) and has accepted a bid by the Supplier for the supply of those goods and services for the sum of One Million Four Hundred Twenty-Four Thousand Eight Hundred Pesos (PhP1,424,800.00), inclusive of all applicable taxes (the "Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively
  assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral parts of this Agreement, viz.:
  - a. Philippine Bidding Documents ("PBDs");
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any;
  - Supplier's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - c. Bid form, including all the documents/statements contained in the Supplier's bidding envelopes, as annexes, and all other documents submitted (e.g., Supplier's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Entity's bid evaluation;
  - d. Performance Security;
  - e. Notice of Award of Contract; and the Supplier's conforme thereto; and
  - f. Other contract documents that may be required by existing laws and/or the Entity concerned in the PBDs.

The Supplier agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration of the Contract Price, the Supplier agrees to provide the goods and services required and to remedy any defects therein in accordance with its bid.
- 4. The Entity agrees to pay the Supplier, in consideration of the provision of the goods and execution of the services, the Contract Price or such other sum as may become payable under the provisions of this Agreement at the times and manner prescribed.
