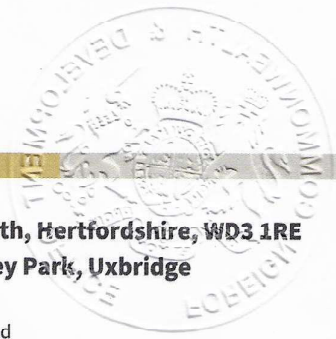
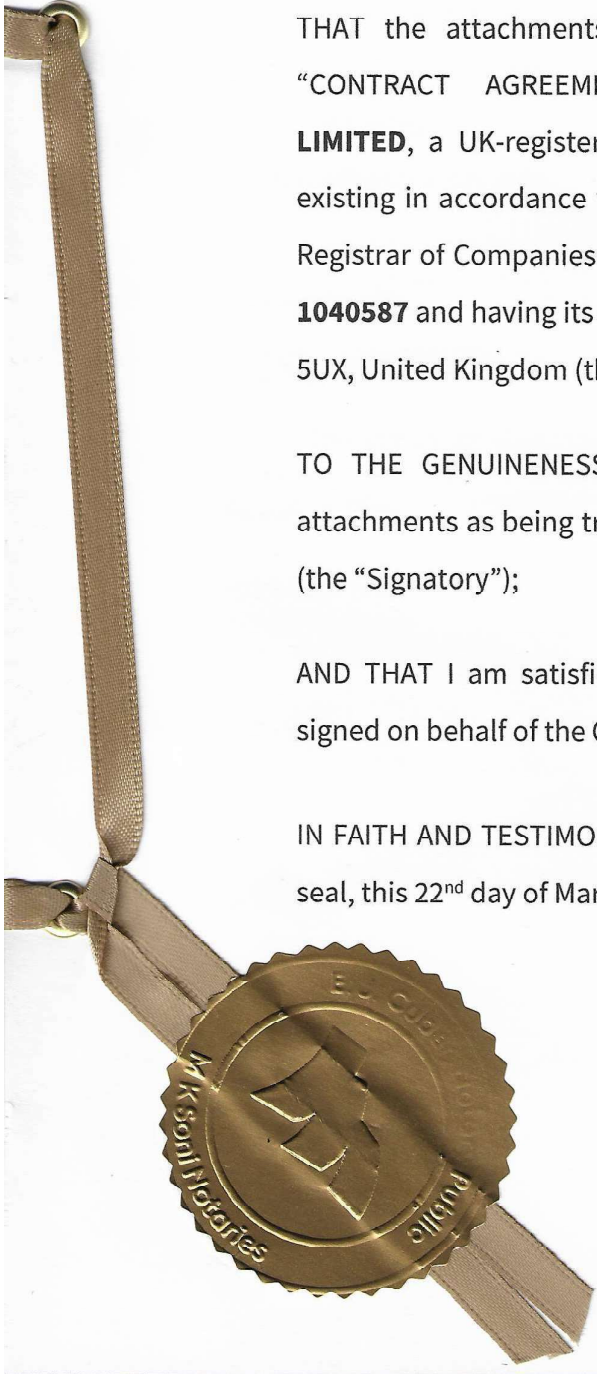



CONTRACT AGREEMENT

PURCHASE OF EUROMONITOR – PASSPORT ONLINE SUBSCRIPTION

THIS AGREEMENT made on the 26 day of FEBRUARY 2022 between the *Philippine Competition Commission (PCC)*, represented by its Executive Director, Kenneth V. Tanate, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "*the Entity*") and *Euromonitor International Limited* represented by its Director, Christopher John Radclyffe Wetherall, with registered office at 60-61 Britton Street, London, EC1M 5UX United Kingdom (hereinafter called "*the Service Provider*") (collectively herein referred to as "Parties");

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *Euromonitor – Passport Online Subscription* and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of *Forty Thousand Nine Hundred Thirty-Two and 27/100 US Dollars (USD 40,932.27) or Two Million Forty-Three Thousand Ninety-Three Pesos and 13/100 (PhP2,043,093.13)* inclusive of all applicable taxes and with net amount of Twenty-Seven Thousand Four Hundred Ten US Dollars (USD 27,410.00), (hereinafter called "the Contract Price"), and with contract duration of twelve (12) months from the signing of the Contract.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Price Quotation;
 - (b) PhilGEPS Registration;
 - (c) Mayor's Permit or equivalent document;
 - (d) Income Tax Return or equivalent document;
 - (e) Sole Distributor Statement;
 - (f) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (g) Other contract documents that may be required by existing laws and/or the Entity (e.g., warranty security).
3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby covenants with the Entity to execute and complete the project and remedy any defects therein in conformity in all respects with the provision of the Contract.
4. The Entity hereby agrees to pay the Service Provider in consideration of the execution and completion of the project, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

IN WITNESS whereof, the Parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
