CONTRACT AGREEMENT

**SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF SESSION
BORDER CONTROLLER (SBC) EQUIPMENT FOR THE PHILIPPINE
COMPETITION COMMISSION (PCC)**

THIS AGREEMENT made on the 3rd day of December 2020 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "*the Entity*") and *American Technologies Inc.* represented by its Senior Account Executive, Frediliza G. Tayobana with business address at No. 5 Ideal St., cor. McCollough St., Brgy. Addition Hills, Mandaluyong City, (hereinafter called "*the Supplier*");

WHEREAS the Entity requested for quotation for certain consulting services for the *Supply, Delivery, Installation and Configuration of Session Border Controller (SBC) Equipment for the Philippine Competition Commission (PCC)* and has accepted a Bid by the Supplier for the goods and services in the sum of *One Million Six Hundred Eighty-Five Thousand Thirty Pesos (PhP1,685,030.00)* inclusive of all applicable taxes (hereinafter called "*the Contract Price*");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Consultant's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
 - (b) the Conditions of Contract;
 - (c) the Conformed Terms of Reference;
 - (d) the Eligibility Documents;
 - (e) the Performance Security; and
 - (f) the Entity's Notice of Award.
2. In consideration of the payments to be made by the Entity to the Supplier as stated above, the Supplier hereby agrees to provide the Entity the said goods and services, and to remedy defects therein in conformity in all respects with the provisions of the Contract.
3. The Entity hereby agrees to pay the Supplier, in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price at the time and in the manner prescribed by the Contract.


