CONTRACT ACREEMENT

SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF SESSION BORDER CONTROLLER (SBC) EQUIPMENT FOR THE PHILIPPINE COMPETITION COMMISSION (PCC)

THIS AGREEMENT made on the 3rd day of December 2020 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "the Entity") and American Technologies Inc. represented by its Senior Account Executive, Frediliza G. Tayobana with business address at No. 5 Ideal St., cor. McCollough St., Brgy. Addition Hills, Mandaluyong City, (hereinafter called "the Supplier"):

WHEREAS the Entity requested for quotation for certain consulting services for the Supply, Delivery, Installation and Configuration of Session Border Controller (SBC) Equipment for the Philippine Competition Commission (PCC) and has accepted a Bid by the Supplier for the goods and services in the sum of One Million Six Hundred Eighty-Five Thousand Thirty Pesos (PhP1,685,030.00) inclusive of all applicable taxes (hereinafter called "the Contract Price"):

- 2. In consideration of the payments to be made by the Entity to the Supplier as stated above, the Supplier hereby agrees to provide the Entity the said goods and services, and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 3. The Entity hereby agrees to pay the Supplier, in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price at the time and in the manner prescribed by the Contract.
