

CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE ENGAGEMENT OF HIGHLY TECHNICAL CONSULTANT FOR THE CONDUCT OF INDEPENDENT EVALUATION OF QUALITY ASSESSMENT FOR PCC CASES

THIS AGREEMENT is made and entered into on the 11th day of May 2021 by and between: the **Philippine Competition Commission (PCC)** with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "**the Entity**") and **Dr. Gabriel Angelo Domingo**, with office address at Apt 1107 Parc Royale Condominium, Jade Drive, San Antonio, Pasig City, (hereinafter called "**the Consultant**") (collectively herein referred to as "**the Parties**"):

2. In consideration of the payments to be made by the Entity to the Consultant as stated above, the Consultant hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
3. The Entity hereby agrees to pay the Consultant, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.


