CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of January 2022 between the **Philippine Competition** Commission (PCC), represented herein by its Executive Director and Head of Procuring Entity, Kenneth V. Tanate, PhD. with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "the Entity") and **Oilempire, Inc.**, represented herein by its President, Anthony V. Malixi, with office address at #8 Greystone St., White Plains, Quezon City (hereinafter called "the Supplier") (collectively referred to herein as the "Parties");

WHEREAS, the Entity invited bids for certain goods and ancillary services for the "Procurement of Fuel Through Fleet Card Services for the Philippine Competition Commission for C.Y. 2022" and has accepted a bid by the Supplier, declared to have the lowest calculated and responsive bid, for the supply of those goods and services in the sum of Two Million Three Hundred Sixty-Five Thousand Five Hundred Eighty-Six Pesos and 77/100 (Php 2,365,586.77), (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - a. The Conformed Terms of Reference:
 - b. The Supplier's bid, including the Technical and Financial Proposals;
 - c. PhilGEPS Registration;
 - d. Mayor's Permit or equivalent document;
 - e. Income Tax Return or equivalent document;
 - f. Notarized Certificate of Proprietorship/Distributorship;
 - g. Performance Security;
 - h. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - i. Other contract documents that may be required by existing laws and/or the Entity.

The Supplier agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration of the payments to be made by the Entity to the Supplier as stated above, the Supplier hereby agrees to provide to the Entity the said goods and services, complete the same and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby agrees to pay the Supplier, in consideration of the provision of the goods and execution of the services and the remedying of defects therein, the Contract Price or such other sum asmay become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
