

**“PROVISION OF HUMAN RESOURCE SERVICES FOR THE PHILIPPINE  
COMPETITION COMMISSION FOR C.Y. 2022”**

**CONTRACT AGREEMENT**

THIS AGREEMENT made the 13<sup>th</sup> day of January 2022 between the **Philippine Competition Commission** (hereinafter called “the Entity”), represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower I, North Avenue, Quezon City (hereinafter called “the Entity”) and **LSERV Corporation**, represented herein by its Vice President, Generoso T. Canlas, Jr., with office address at Units C & D, 21F Petron Mega Plaza 358 Sen. Gil Puyat Ave., Makati City (hereinafter called “the Service Provider”) (collectively herein referred to as “Parties”);

WHEREAS, the Entity invited Bids for certain services for the **Provision of Human Resource Services for the Philippine Competition Commission for C.Y. 2022** and has accepted a Bid by the Service Provider for the provision of those services in the sum of **Twenty Million Two Hundred Thirteen Thousand Five Hundred Four Pesos and 28/100 (Php20,213,504.28)**, inclusive of all applicable taxes (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract and the Bidder’s conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider agrees to provide the services, complete the same and to remedy the defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
