# CONTRACT AGREEMENT FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE DESIGN AND PRODUCTION OF PCC PUBLICATION ON FOSTERING COMPETITION IN THE PHILIPPINES

THIS AGREEMENT is made and entered into on the \_\_\_\_\_ day of June 2022 by and between the *Philippine Competition Commission (PCC)* with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director Kenneth V. Tanate, PhD. (hereinafter called "the Entity") and *Studio 5 Designs, Inc.* with office address at Unit 3022, Beacon, Amorsolo Tower 3, Don Chino Roces Avenue cor. Arnaiz Street, Legazpi Village, Makati City, represented herein by its President, Ms. Maria Lydia Y. Orosa a.k. a Marily Y. Orosa, (hereinafter called "the Service Provider", collectively herein referred to as "the Parties").

WHEREAS, the Entity requested for submission of bids for the Procurement of Consulting Services for the Design and Production of PCC Publication on Fostering Competition in the Philippines and has accepted a Bid by the Service Provider for the consulting services in the sum of Two Million Forty-Nine Thousand Six Hundred Pesos (Php2,049,600.00), inclusive of all applicable taxes (hereinafter called "the Contract Price");

e. Performance Security:

- f. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
- Other contract documents that may be required by existing laws and/or the Entity.

The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
