

CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE DESIGN AND PRODUCTION OF PCC PUBLICATION ON FOSTERING COMPETITION IN THE PHILIPPINES

THIS AGREEMENT is made and entered into on the ___ day of June 2022 by and between the *Philippine Competition Commission (PCC)* with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director Kenneth V. Tanate, PhD. (hereinafter called "the Entity") and *Studio 5 Designs, Inc.* with office address at Unit 3022, Beacon, Amorsolo Tower 3, Don Chino Roces Avenue cor. Arnaiz Street, Legazpi Village, Makati City, represented herein by its President, Ms. Maria Lydia Y. Orosa a.k.a Marily Y. Orosa, (hereinafter called "the Service Provider", collectively herein referred to as "the Parties").

WHEREAS, the Entity requested for submission of bids for the *Procurement of Consulting Services for the Design and Production of PCC Publication on Fostering Competition in the Philippines* and has accepted a Bid by the Service Provider for the consulting services in the sum of *Two Million Forty-Nine Thousand Six Hundred Pesos (Php2,049,600.00)*, inclusive of all applicable taxes (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Conformed Terms of Reference;
 - b. Supplier's bid, including the Technical and Financial Proposals;
 - c. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted, including corrections to the bid, if any, resulting from the Entity's bid evaluation;
 - d. Eligibility requirements, documents and/or statements;
 - e. Performance Security;
 - f. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - g. Other contract documents that may be required by existing laws and/or the Entity.


The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the Contract Price or such other sums as may be ascertained, the Service Provider hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects in accordance with its Bid.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
