## CONTRACT AGREEMENT

### CONTRACT AGREEMENT FOR THE PROVISION OF CONSULTING SERVICES FOR THE CONTENT DEVELOPMENT OF PCC PUBLICATION ON FOSTERING COMPETITION IN THE PHILIPPINES

THIS AGREEMENT is made and entered into on the \_\_\_ day of \_\_\_\_\_ 2021 by and between: the *Philippine Competition Commission (PCC)* with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "**the Entity**") and *COMS 360 Inc.*, represented by its Strategic Communications Manager & Development Cluster Head, Ms. Rachel Angela A. Gutierrez, with office address at 4F LTA Bldg., 118 Perea Street, Legazpi Village, Makati City, (hereinafter called "**the Service Provider**") (collectively herein referred to as "**the Parties**");

WHEREAS, the Entity requested for submission of bids for the *Provision of Consulting Services for the Content Development of PCC Publication on Fostering Competition in the Philippines* and has accepted a Bid by the Service Provider for the consulting services in the sum of *Nine Hundred Eighty-Three Thousand Nine Hundred Twenty Pesos (Php 983,920.00)*, inclusive of all applicable taxes (hereinafter called "**the Contract Price**");


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Consultant's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - (b) the Conditions of Contract;
  - (c) the Conformed Terms of Reference;
  - (d) the Eligibility Documents;
  - (e) the Performance Security; and
  - (f) the Entity's Notice of Award.
2. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
3. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.

IN WITNESS whereof the Parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




