CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE PROVISION OF CONSULTING SERVICES FOR THE CONTENT DEVELOPMENT OF PCC PUBLICATION ON FOSTERING COMPETITION IN THE PHILIPPINES

THIS AGREEMENT is made and entered into on the day of between: the Philippine Competition Commission (PCC) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "the Entity") and COMS 360 Inc., represented by its Strategic Communications Manager & Development Cluster Head, Ms. Rachel Angela A. Gutierrez, with office address at 4F LTA Bldg., 118 Perea Street, Legazpi Village, Makati City, (hereinafter called "the Service Provider") (collectively herein referred to as "the Parties"):

 - (e) the Performance Security; and
 - (f) the Entity's Notice of Award.
- In consideration of the payments to be made by the Entity to the Service Provider as stated 2. above, the Service Provider hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- The Entity hereby agrees to pay the Service Provider, in consideration of the provision of 3. the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
