

CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE PROCUREMENT OF PROFESSIONAL SERVICES FOR THE CONDUCT OF A NATIONWIDE MARKET SURVEYS ON THE NON-ALCOHOLIC BEVERAGE MARKET IN THE PHILIPPINES

THIS AGREEMENT is made and entered into on the ___ day of _____ 2021 by and between *Philippine Competition Commission* ("PCC") represented herein by its Executive Director and Head of Procuring Entity, Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter referred to as "**the Entity**") and *Philippine Survey & Research Center, Inc.*, represented herein by its Executive Director, Judith Rachel R. Mercado, with office address at 10/F OMM Citra Bldg, San Miguel Ave., Ortigas Center, San Antonio, Pasig City (hereinafter referred to as "**the Service Provider**" or "**the Bidder**") (collectively herein referred to as "**the Parties**");

WHEREAS, the Entity requested bids for the *Procurement of Professional Services for the Conduct of A Nationwide Market Surveys on the Non-Alcoholic Beverage Market in the Philippines* and has accepted a Bid by the Service Provider for consulting services in the sum of *One Million Six Hundred Thousand Pesos (Php 1,600,000.00)*, inclusive of all applicable taxes (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 ("2016 RIRR") shall be attached, deemed to form and be read and construed as part of this Agreement, *to wit*:
 - a. The Conformed Terms of Reference;
 - b. The Service Provider's bid, including the Technical and Financial Proposals;
 - c. PhilGEPS Registration;
 - d. Mayor's Permit or equivalent document;
 - e. Income Tax Return or equivalent document;
 - f. Notarized Certificate of Proprietorship/Distributorship;
 - g. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - h. Other contract documents that may be required by existing laws and/or the Entity.

The Service Provider agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide to the Entity the said services, complete the same, and remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may



become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.


