# CONTRACT AGREEMENT FOR THE PROCUREMENT OF CONSULTANCY SERVICES FOR THE CONDUCT OF MARKET SURVEYS AMONG MICRO SMALL AND MEDIUM ENTERPRISES

THIS AGREEMENT is made and entered into on the **22**<sub>M</sub> day of October 2021 by and between: the **Philippine Competition Commission** (**PCC**) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "the Entity") and **The All-Asian Centre for Enterprise Development, Inc.** represented by Atty. Rodrigo O. Celicious with office address at U-103, CTP Alpha Tower, Investment Drive, Madrigal Business Park, Alabang, Muntinlupa City, (hereinafter called "the Service Provider") (collectively herein referred to as "the Parties");

  - (c) the Conformed Terms of Reference;
  - (d) the Eligibility Documents;
  - (e) the Performance Security;
  - (f) the Entity's Notice of Award and the Bidder's conforme thereto; and
  - (g) Other contract documents that may be required by existing laws and/or the Entity.
- 2. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 3. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
