CONTRACT AGREEMENT

PROCUREMENT OF REAL ESTATE MARKET DATA AND MAPPING TOOL

THIS AGREEMENT made on the <u>valory</u> day of <u>valory</u> between the **Philippine Competition Commission** ("PCC"), represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter referred to as "the Entity") and **Jones Lang LaSalle** (**Philippines**), **Inc.** represented by its Country Head, Christophe Vicic, with registered office address at 19/F Ayala Avenue, Makati City (hereinafter referred to as the "the Service Provider") (collectively herein referred to as "the Parties"):

WHEREAS, the Entity requested the Service Provider, who holds exclusive rights under a licensing agreement to the platform MapIT, a location intelligence service that provides global access to information and Geographic Information System tools, to submit its quotation for the *Procurement of Real Estate Market Data and Mapping Tool* through Direct Contracting and has accepted the quotation submitted for the provision of services in the sum of *Four Million Philippine Pesos (PhP4,000,000.00)*, inclusive of all applicable taxes (hereinafter called "the Contract Price"):

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 ("2016 RIRR") shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) The Terms of Reference;
 - (b) The Service Provider's submitted Price Quotation;
 - (c) PhilGEPS Registration;
 - (d) Mayor's Permit or equivalent document;
 - (e) Income Tax Return or equivalent document;
 - (f) Notarized Certificate of Proprietorship/Distributorship;
 - (g) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (h) Other contract documents that may be required by existing laws and/or the Entity. The Service Provider agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to execute and complete the project and remedy any defects therein in conformity in all respects with the provision of the Contract.

4. The Entity hereby agrees to pay the Service Provider in consideration of the execution and completion of the project, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
