CONTRACT AGREEMENT

14 JAN 2022

THIS AGREEMENT made on the _____ day of _____ between the **Philippine Competition Commission** (PCC), represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called "the Entity") and **Ynzal Marketing Corporation**, represented herein by its Business Development Consultant, Jane A. Dungca, with office address at #20 Scout Limbaga St. Brgy. Laging Handa, Quezon City (hereinafter called "the Supplier") (collectively herein referred to as "Parties");

WHEREAS, the Entity invited Bids for certain goods and ancillary services for the *Subscription of Enterprise Cloud-based E-signature Service for the Philippine Competition Commission* and has accepted a Bid by the Supplier, declared as the single calculated responsive bid, for the supply of these goods and services in the sum of *One Million Four Hundred Twenty-Seven Thousand Two Hundred Pesos (PhP1,427,200.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. The Conformed Terms of Reference;
 - b. The Service Provider's bid, including the Technical and Financial Proposals;
 - c. PhilGEPS Registration;
 - d. Mayor's Permit or equivalent document;
 - e. Income Tax Return or equivalent document;
 - f. Notarized Certificate of Proprietorship/Distributorship;
 - g. Performance Security;
 - h. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - i. Other contract documents that may be required by existing laws and/or the Entity.


The Service Provider agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide to the Entity the said services, complete the same and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
