

## CONTRACT AGREEMENT

### CONTRACT AGREEMENT FOR THE PROCUREMENT OF CONSULTANCY SERVICES FOR THE CONDUCT OF MARKET SURVEYS AMONG CONSUMERS

THIS AGREEMENT is made and entered into on the \_\_\_ day of \_\_\_\_\_ 2021 by and between: the **Philippine Competition Commission (“PCC”)** represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter referred to as “**the Entity**”) and **Philippine Survey & Research Center, Inc.**, represented herein by its Executive Director, Judith Rachel R. Mercado with office address at 10/F OMM Citra Bldg, San Miguel Ave., Ortigas Center, San Antonio, Pasig City. (hereinafter referred to as “**the Service Provider**” or “**the Bidder**”) (collectively herein referred to as “**the Parties**”):

WHEREAS, the Entity requested bids for the **Procurement of Consultancy Services for the Conduct of Market Surveys among Consumers** and has accepted a Bid by the Service Provider for consulting services in the sum of **Two Million Forty-Nine Thousand Nine Hundred Two Pesos and Forty Centavos (Php 2,049,902.40)**, inclusive of all applicable taxes (hereinafter called “**the Contract Price**”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, *to wit*:
  - (a) the Service Provider’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - (b) the Conditions of Contract;
  - (c) the Conformed Terms of Reference;
  - (d) the Eligibility requirements, documents, and/or statements;
  - (e) the Performance Security;
  - (f) Credit line issued by a licensed bank, if any;
  - (g) the Entity’s Notice of Award of Contract and the Bidder’s conforme thereto; and
  - (h) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide to the Entity the said services, complete the same, and remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
