

CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE PROCUREMENT OF MANAGEMENT SERVICES FOR VOICE-OVER INTERNET PROTOCOL TELECOMMUNICATION SYSTEM FOR THE PHILIPPINE COMPETITION COMMISSION FOR CALENDAR YEAR 2021

THIS AGREEMENT made on the **27th** day of January 2021 between the *Philippine Competition Commission (PCC)* with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City 1105 (hereinafter called the “*Entity*”) and *PLDT Inc.* with business address at Ramon Cojuangco Building, Makati Avenue, Makati City (hereinafter called the “*Service Provider*”):

WHEREAS, the Entity invited bids for the *Procurement of Management Services for Voice-over Internet Protocol Telecommunication System for the Philippine Competition Commission for Calendar Year 2021* and has accepted a Bid by the Service Provider for the provision of said goods and services in the sum of *Two Million Five Hundred Fifty Thousand Pesos (PhP2,550,000.00)*, inclusive of all applicable taxes (hereinafter called “the Contract Price”), less pro-rata amount for telecommunication services not rendered prior to receipt of Notice to Proceed, and subject to contract renewal pursuant to Appendix 21 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the General and Special Conditions of Contract;
 - (b) the Terms of Reference and the Bidder’s conforme thereto;
 - (c) the Instructions to Bidders;
 - (d) the Bid Data Sheet;
 - (e) the Supplemental/Bid Bulletins (if any);
 - (f) the Bid forms, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents/statements submitted;
 - (g) the Eligibility requirements, documents and/or statements;
 - (h) the Performance Security;
 - (i) the Notice of Award of Contract and the Bidder’s conforme thereto;
 - (j) Other contract documents that may be required by existing laws and/or the Entity.
2. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby agrees to provide the Entity the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
3. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.




