



CONTRACT AGREEMENT

PROVISION OF CONSOLIDATED ICT SECURITY SOFTWARE SUBSCRIPTIONS FOR THE PHILIPPINE COMPETITION COMMISSION – LOT 4: BACKUP SOFTWARE

THIS AGREEMENT made on the _____th day of **JAN 20 2021** between the **Philippine Competition Commission (PCC)**, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called “the Entity”) and **Infocentric Solution, Inc.** represented by its Sales Manager, Ms. Marjorie A. Ona, with business address at 200 Canley Road Brgy. Bagong Ilog, Pasig City, (hereinafter called “the Supplier”) (collectively herein referred to as “Parties”):

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Provision of Consolidated ICT Security Software Subscriptions for the Philippine Competition Commission – Lot 4: Backup Software** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Hundred Ninety Nine Thousand Eight Hundred Eighty Pesos (PhP 599,880.00)**, inclusive of all applicable taxes (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that



are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of *Five Hundred Ninety Nine Thousand Eight Hundred Eighty Pesos (PhP 599,880.00)*, or such other sums as may be ascertained, the Supplier agrees to the *Provision of Consolidated ICT Security Software Subscriptions for the Philippine Competition Commission – Lot 4: Backup Software* in accordance with its Bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
