

## Engagement of an Event Management Consulting Firm for the East Asia Top-Level Officials Meeting and East Asia Conference

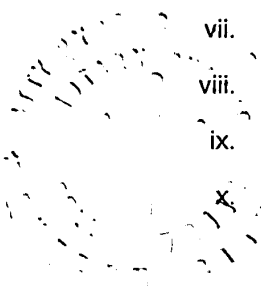
### CONTRACT AGREEMENT

This AGREEMENT is made on the 15 day of SEP, 2022 between the **Philippine Competition Commission (PCC)** with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City of the Philippines (hereinafter called "the Entity") and **Total Exhibit and Expo Solutions, Inc.** with office address at #7 Sunshine Lane, Rodriguez Subd. Rodriguez Drive, Brgy. Baesa, Quirino Hwy, Quezon City (hereinafter called "the Service Provider");

WHEREAS, the Entity invited Bids for event management, particularly the **Engagement of an Event Management Consulting Firm for the East Asia Top-Level Officials Meeting and East Asia Conference** (hereinafter called "the Project") and has accepted a Bid from the Service Provider, declared as the Highest Rated and Responsive Bidder, for the delivery of said services in the sum of **One Million Seven Hundred Sixty-Four Thousand Pesos (PhP1,764,000.00)**, inclusive of all applicable taxes (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. General and Special Conditions of the Contract;
  - ii. Terms of Reference;
  - iii. Request for Expression of Interest;
  - iv. Bid Data Sheet;
  - v. Addenda and/or Supplemental/Bid Bulletin, if any;
  - vi. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - vii. Eligibility requirements, documents and/or statements;
  - viii. Performance Security;
  - ix. Notice of Award of Contract and the Bidder's conforme thereto; and
  - x. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in accordance with its Bid.

This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.



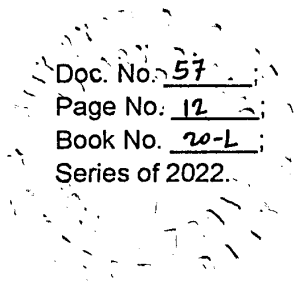
