





CONTRACT AGREEMENT

PROCUREMENT OF COMPREHENSIVE ICT MAINTENANCE SERVICES FOR THE PCC DATA CENTER INFRASTRUCTURE – LOT 2: NETWORK SWITCHES AND WIRELESS DEVICES

THIS AGREEMENT made this 20 day of JAN 2021 20__ between the **Philippine Competition Commission (PCC)**, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called “the Entity”) and **Microdata Systems and Management, Inc.** represented by its Business Development Manager, Mr. Jun F. Mortero, with business address at Crystal Bldg. 199 C.M. Recto cor. A. Mabini St., San Juan City (hereinafter called “the Supplier”) (collectively herein referred to as “Parties”):

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Procurement of Comprehensive ICT Maintenance Services for the PCC Data Center Infrastructure – Lot 2: Network Switches and Wireless Devices** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Six Hundred Eighty-Eight Thousand Eight Hundred Sixty Pesos and 96/100 (PhP 1,688,860.96)**, inclusive of all applicable taxes (hereinafter called “the Contract Price”).


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iv. Performance Security;
 - v. Notice of Award of Contract and the Bidder’s conforme thereto; and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the

Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of *One Million Six Hundred Eighty-Eight Thousand Eight Hundred Sixty Pesos and 96/100 (PhP 1,688,860.96)*, or such other sums as may be ascertained, the Supplier agrees to the *Procurement of Comprehensive ICT Maintenance Services for the PCC Data Center Infrastructure – Lot 2: Network Switches and Wireless Devices* in accordance with its Bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
