CONTRACT AGREEMENT

PROCUREMENT OF COMPREHENSIVE ICT MAINTENANCE SERVICES FOR THE PCC DATA CENTER INFRASTRUCTURE – LOT 5: PRECISION AIRCONDITIONING SYSTEM

THIS AGREEMENT made this 21 day of January 2021 between the ***Philippine Competition Commission (PCC)***, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called “the Entity”) and ***American Technologies, Inc.*** represented by its Senior Business Unit Head, Mr. Charlie Torreliza, with business address at #5 Ideal cor. Mc Collough St. Addition Hills, Mandaluyong City (hereinafter called “the Supplier”):

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the ***Procurement of Comprehensive ICT Maintenance Services for the PCC Data Center Infrastructure – Lot 5: Precision Airconditioning System*** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of ***Nine Hundred Fifty-Two Thousand Pesos (PhP952,000.00)***, inclusive of all applicable taxes (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iv. Performance Security;
 - v. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the
