## CONTRACT AGREEMENT

### 2021 NATIONAL SURVEY ON THE AWARENESS OF GOVERNMENT ENTITIES ON THE PHILIPPINE COMPETITION ACT AND THE PHILIPPINE COMPETITION COMMISSION

---

THIS AGREEMENT made on the 26th day of February 2021 between the **Philippine Competition Commission (PCC)**, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "**the Entity**") and **Philippine Survey and Research Center, Inc.** represented by its Executive Director, Ms. Judith Rachel R. Mercado with business address at 21F OMM-Citra Bldg., San Miguel Avenue, Pasig City, hereinafter called "**the Service Provider**") (collectively herein referred to as "**the Parties**");

WHEREAS the Entity requested for submission of bids for the **Procurement of 2021 National Survey on the Awareness of Government Entities on the Philippine Competition Act and the Philippine Competition Commission** and has accepted a Bid by the Service Provider for the consulting services in the sum of **Four Million One Hundred Fifty Thousand Pesos (Php 4,150,000.00)** inclusive of all applicable taxes (hereinafter called **the "Contract Price"**);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Consultant's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - (b) the Conditions of Contract;
  - (c) the Conformed Terms of Reference;
  - (d) the Eligibility Documents;
  - (e) the Performance Security; and
  - (f) the Entity's Notice of Award.
2. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide the Entity the said services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
3. The Entity hereby agrees to pay the Service Provider, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
