

CONTRACT AGREEMENT

THIS AGREEMENT made the **DEC 10 2021** of December 2021 between the **Philippine Competition Commission** (PCC) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City (hereinafter called “the Entity”) of the one part and **Infocentric Solutions, Inc.** with office address at 19/F Marco Polo Ortigas Manila Sapphire Road, Ortigas Center, San Antonio, Pasig City (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services for the **Supply, Delivery, Installation and Testing of Information and Communication Technology Equipment for the Philippine Competition Commission Data Center Infrastructure - Lot 1: Hyperconverged Server Infrastructure** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Ten Million Four Hundred Eighty-Five Thousand Five Hundred Pesos (PhP 10,485,500.00)**, (hereinafter called “the Contract Price”).


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
3. In consideration for the sum of Ten Million Four Hundred Eighty-Five Thousand Five Hundred Pesos (PhP 10,485,500.00), Infocentric Solutions, Inc. agrees to provide the services and to remedy the defects therein in accordance with his/her/its Bid.
4. The Philippine Competition Commission agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


