

**CONTRACT AGREEMENT**

**MANPOWER SERVICES PROVIDER FOR THE ADMINISTRATIVE SUPPORT  
AND GENERAL SERVICES PERSONNEL FOR NOVEMBER – DECEMBER 2020**

THIS AGREEMENT made on the 30 day of OCTOBER 2020 between the *Philippine Competition Commission (PCC)*, with office address at 25/F Tower I, Vertis North Corporate Center, North Avenue Quezon City 1105 (hereinafter called "*the Entity*") of the one part and *LSERV Corporation* represented by its Chief Operating Officer, Mr. Joseph V. Angeles, with business address at Units C & D, 21<sup>st</sup> Floor, Petron Mega Plaza, 358 Sen. Gil Puyat Avenue, Makati City, (hereinafter called "*the Service Provider*") of the other part:

WHEREAS, the Entity entered into Emergency Procurement under Republic Act No. 11494 otherwise known as the Bayanihan to Recover As One Act in accordance with GPPB Resolution No. 18-2020 for the *Procurement of Manpower Services Provider for the Administrative Support and General Services Personnel for November - December 2020* and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of *Two Million Four Hundred Nineteen Thousand Three Hundred Forty Eight Pesos and 59/100 (PhP2,419,348.59)*, inclusive of all applicable taxes (hereinafter called "*the Contract Price*"), effective upon receipt of the Notice to Proceed.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Bid Form;
  - (b) Terms of Reference;
  - (c) Eligibility requirements, documents and/or statements; and
  - (d) Notice of Award of Contract and the Bidder's conforme thereto.
3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to execute and complete the project and remedy any defects therein in conformity with the provisions of this Service Provider in all respects.
4. The Entity hereby agrees to pay the Service Provider in consideration of the execution and completion of the project, the Contract Price or such other sum as may become payable under the provisions of this Agreement at the times and in the manner prescribed by this Agreement.
