CONTRACT AGREEMENT

CONTRACT AGREEMENT FOR THE PROVISION OF SECURITY SERVICES FOR THE PHILIPPINE COMPETITION COMMISSION FOR CY 2022

THIS AGREEMENT made on the Competition Commission (PCC), represented herein by its Executive Director and Head of Procuring Entity Kenneth V. Tanate, PhD., with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City 1105 (hereinafter called the "Entity"), and Circa Security and Investigation, Inc., represented herein by its Security Director for Administration, Ritchie R. Gonzales, with business address at 30A Goldstar Bldg., Malhacan Road, Malhacan, Meycauayan City, Bulacan (hereinafter called the "Service Provider") (collectively herein referred to as "Parties"):

WHEREAS, the Entity invited bids for the *Provision of Security Services for the Philippine Competition Commission for CY 2022* and has accepted a Bid by the Service Provider, declared as the bidder with the Lowest Calculated and Responsive Bid, for the provision of said services in the sum of Eight Hundred Fifty-Six Thousand Four Hundred Ninety-Three Pesos and Forty Centavos (PhP856,493.40), inclusive of all applicable taxes (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. The Conformed Terms of Reference;
 - b. The Service Provider's bid, including the Technical and Financial Proposals;
 - c. PhilGEPS Registration;
 - d. Mayor's Permit or equivalent document;
 - e. Income Tax Return or equivalent document;
 - f. Notarized Certificate of Proprietorship/Distributorship;
 - g. Performance Security;
 - h. Notice of Award of Contract and the Bidder's conforme thereto; Conditions of Contract; and
 - i. Other contract documents that may be required by existing laws and/or the Entity.

The Service Provider agrees that additional contract documents or information prescribed by the GPBB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby agrees to provide to the Entity the said
