

Provision of Consulting Services to Conduct Digital Media Advertising Placements for Stakeholder Awareness and Competition Enforcement

CONTRACT AGREEMENT

THIS AGREEMENT made on the ___ day of September 2022 between the **Philippine Competition Commission (PCC)** with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City, represented herein by its Executive Director, Kenneth V. Tanate, PhD (hereinafter called the "Entity" or "PCC"), and **PurpleBug, Inc.** with office address at Unit 806 Antel 2000 Corporate Center 121 Valero St. Salcedo Village, Makati City, represented herein by its President, Marlon A. Gonzales (hereinafter called "the Service Provider");

WHEREAS, the Entity invited Bids for the procurement of the **Provision of Consulting Services to Conduct Digital Media Advertising Placements for Stakeholder Awareness and Competition Enforcement**, and has accepted a Bid from the Service Provider, declared as the Single Rated and Responsive Bidder, for the delivery of said services in the sum of **Five Million One Hundred Twenty-One Thousand One Hundred Thirty Pesos and 80/100 (PhP5,121,130.80)**, inclusive of all applicable taxes (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. General and Special Conditions of the Contract;
 - ii. Terms of Reference;
 - iii. Request for Expression of Interest;
 - iv. Bid Data Sheet;
 - v. Addenda and/or Supplemental/Bid Bulletin, if any;
 - vi. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - vii. Eligibility requirements, documents and/or statements;
 - viii. Performance Security;
 - ix. Notice of Award of Contract and the Bidder's conforme thereto; and
 - x. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Philippine Bidding Documents. The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby covenants with the Entity to execute and

complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Agreement in accordance to its Bid.


4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement shall be effective as deliver of a manually executed counterpart of this Agreement.




