CONTRACT AGREEMENT

THIS AGREEMENT made on the _ day of October 2022 between the Philippine Competition Commission (PCC) with office address at 25/F Vertis North Corporate Center Tower 1, North Avenue, Quezon City of the Philippines (hereinafter called "the Entity" or "PCC"), represented herein by its Executive Director, Kenneth V. Tanate, PhD, and Philippine Survey and Research Center, Inc. (PSRC, Inc.) with office address at 21/F OMM-Citra Bldg., San Miguel Ave., Ortigas Center, Pasig City (hereinafter called "the Service Provider"), represented herein by its Executive Director, Judith Rachel R. Mercado;

WHEREAS, the Entity invited Bids for the Procurement of Consultancy Services for the Conduct of Market Survey among Consumers and has accepted a Bid from the Service Provider, declared as the Single Rated and Responsive Bidder, for the delivery of said services in the sum of One Million Eighty-Five Thousand Pesos (PhP1,085,000.00), inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

 - ٧. Addenda and/or Supplemental/Bid Bulletin, if any;
 - Bid forms, including all the documents/statements contained in the Bidder's vi. bidding envelopes, as annexes, and all other documents/ statements submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - Eligibility requirements, documents and/or statements; vii.
 - viii. Performance Security;
 - Notice of Award of Contract and the Bidder's conforme thereto; and İΧ.
 - Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The Service Provider agrees that additional contract documents or information prescribed by the Government Procurement Policy Board that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration of the payments to be made by the Entity to the Service Provider as stated above, the Service Provider hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Service Provider in all respects.
