## Executive Summary: Commitments on the Proposed Acquisition by Universal Robina Corporation of Assets of Central Azucarera Don Pedro, Inc. and Roxas Holdings, Inc. (M-2018-021)

The Philippine Competition Commission (PCC) invites stakeholders, sugar millers, sugar producers, farmers, and interested individuals to submit comments on the commitments proposed in the acquisition by Universal Robina Corporation (URC) of assets of Central Azucarera Don Pedro, Inc. (Don Pedro) and Roxas Holdings, Inc. (RHI).

The proposed commitments include the following provisions:

Section A. The Commitment to Increase Sugar Recovery Rates Section B. The Commitment to Perform Capital Upgrades Section C. The Commitment to Maintain Trucking Allowances Section D. The Commitment to Provide Planter Assistance Section E. The Commitment on Sharing Ratios Section F. Commitment Regarding Feedback from Stakeholders Section G. Variation, Substitution, or Release of Commitments Section H. Entry Into Force

URC, is a subsidiary of JG Summit Holdings, Inc., and is engaged in a wide range of food-related business, including the production of packed goods and beverages, sugar, agro-industrial products, and bioethanol. URC, through its Sugar Division, operates six (6) sugar cane mills. Don Pedro, on the other hand, is a wholly-owned subsidiary of Roxas Holdings, Inc. Don Pedro operates an integrated sugar cane milling and refining plant in Nasugbu, Batangas.

URC will acquire all buildings, improvements, machineries and equipment, laboratory equipment, spare parts and transportation equipment, as well as the land on which the aforementioned assets are located, and such other assets which are necessary for the continuing operations of the refinery and milling plant located at Brgy. Lumbanga, Nasugbu, Batangas.
